## Dear Friends of Catholic Charities Community Services,

2013 was a year of significant change for Catholic Charities Community Services ... in leadership, location and funding landscape. Founding executive director Paul Pickering retired after 30 years of service. Our clients, staff and board of directors welcomed Lori VanAuken to the agency in March to serve as the new executive director, bringing with her 25 years of expertise in the not-for-profit field. More leadership change came about in September, when Virgil Joseph assumed the position of Board President, bringing his strong finance background and leadership skills to the helm. After 15 years on East Ridge Road in Irondequoit, we moved our main offices to Water Tower Park on Jay Street, increasing our accessibility for clients and allowing space for future growth. In October, we also expanded our office space in Penn Yan.

On the funding scene, New York State's reimbursement rates were being recalculated, leaving many agencies like ours in precarious positions when it came to budgeting for the future. The Office for People with Developmental Disabilities encouraged agencies to downsize their residential homes and to prepare for a new managed care system for clients. The Medicaid Redesign effort re-classified HIV/AIDS as a chronic illness, and it joined a list of other chronic illnesses, expanding our client base through a new care management service model—Health Homes.

So much change in one year could have been tumultuous and distracting; however, our strong foundation and commitment to our clients allowed us to embrace the opportunities before us. We positioned ourselves for growth ... upgrading technology, securing funding for employment training, and other services to support our clients. We served nearly 1,800 individuals in 2013—almost twice as many as the previous year—with





outreach efforts, case management and supportive services like housing subsidies and life skills training. We continue to position for growth in 2014 by defining our brand, restructuring, and strategic planning.

The Greek philosopher Heraclitus said, "The only thing in life that is constant is change." Here are two more constants at Catholic Charities Community Services:

1) staff members who are driven to provide superior and compassionate services to our clients, and 2) our clients' success living empowered, dignified, and independent lives. 

# Shakeem's Story

Shakeem is a happy and engaging young man who loves music, singing, dancing and animals. When he was born prematurely, Shakeem weighed just over a pound. His early arrival and low birth weight, coupled with an elevated level of lead in his system, left him with a developmental disability.

Growing up, Shakeem did not have a stable home environment, and, after a very challenging childhood, 19-year-old Shakeem was determined not to fall victim to "the streets." He reached out to Catholic Charities Community Services for help.

At Catholic Charities Community Services, Shakeem receives a grant to assist with his rent, he participates in community habilitation services, and receives service coordination. With the assistance of his team at Catholic Charities Community Services, Shakeem has successfully learned to budget his money, grocery shop, drive a car and complete daily living tasks. In 2009, he realized one of his biggest accomplishments when

he moved into his own apartment! Shakeem is now participating in the agency's Consumer Advisory Board, which is a group of consumers from across the agency who play a role in community outreach and who will be facilitating a consumer focus group in fall 2014.

Shakeem was a featured speaker at Catholic Charities Community Service's Breakfast with Friends event, where he shared his life struggles along with the successes that he has achieved while receiving services from Catholic Charities Community Services. In his remarks, Shakeem said, "Catholic Charities Community Services is my family!"

The next accomplishment that Shakeem is actively working toward is becoming a homeowner. He is working with Habitat for Humanity to build a place of his own, which he will share with his young daughter and their family dog. We have no doubt that Shakeem will reach this goal.

# Deniese's Story

In Haiti in the early 1990s, it was a time of great violence. For Deniese, who was born in Haiti and lived there with her young daughter and infant son, the violence came right into her home. One evening soldiers broke into her home and threatened her for information. She found herself thrown to the floor, with a soldier's boot on her head and a gun pointed toward it. The soldiers left her home with a promise to return, so she fled in the night in a very small boat in hopes of reaching the United States.

After her boat nearly capsized and she and the others were rescued by US Coast Guard, she wound up in a refugee camp in Guantanamo Bay. It was at that time that it was discovered that she was positive for HIV. Eventually, she and her baby came to America as refugees and then became permanent residents. After a few years of living in the US, Deniese came to Rochester. It was here that she was referred to Catholic Charities Community Services for assistance.

In 1997, she met with Sr. Jane Schur and began what has become a 17 year partnership with Catholic Charities Community Services. Initially, her case management included getting her into safe housing, obtaining needed medical services and HIV treatment, schooling and ESL (English as a Second Language) training, clothing, food and benefits. In addition to that, Sr. Jane worked

for several years to make it possible for her daughter, who was still in Haiti, to join the rest of the family here in Rochester.

Since then, Deniese and her family have worked with the CCCS team while her children have grown from youngsters into self-sufficient adults who are valuable, contributing members of the Rochester community. Deniese works a full-time job, assists in the community; and is a member of our Consumer Advisory Board, where she has contributed input into our agency identity and services. She received training as a peer educator, and she was a featured speaker for Catholic Charities Community Services. She is also now a United States citizen.

A Catholic Charities Community Services staff person said of Deniese, "She, for me, is hope. She is a bright, shining light for both the staff and our clients. Her very presence shows others how they can overcome odds to reach fulfillment in life and raise tremendous children. And to me, she shows the value of listening with your heart, and to never underestimate the power of standing beside a consumer in solidarity, dignity and respect."

Deniese is the very definition of empowerment, dignity and compassion.

# Melinda's Story

Melinda was born in Rochester, grew up in Auburn, and then moved back here. She had a relatively normal childhood; however, when she was 17 years old, she began to experience several unpleasant symptoms—severe headaches, dizziness and eventually fainting spells. Then when she was a senior in high school, she had a heart attack, for which doctors had no explanation. These symptoms, along with incredible vertigo, the inability to concentrate, and visual disturbances went on for some time. There was a tumor which had grown and taken over her vagus nerve, causing stomach and heart issues as well as breathing problems. By the time she was 20, her doctor realized that her strange symptoms indicated that something was very wrong. She was sent to a specialist, who immediately identified a tumor.

The tumor had taken over her jugular vein and carotid artery, her skull base, all the way up to her eye and into her C1 vertebrae. This required a surgery that was not done by anyone in Rochester. There were two choices—Switzerland or Los Angeles. She chose Los Angeles. The surgery was so risky that the chance of death was 80%, and if she lived, they expected her to be in a vegetative state until death. But Melinda figured if they performed the surgery on her, they could learn how to treat this and maybe it could somehow help someone else in the future. "I could feel my body shutting down. I knew I was going to die soon anyway," says Melinda, "so I had the surgery thinking that if they can't save me, then maybe I can help them save the next person."

But they did save her. After two very risky surgeries during which she suffered two strokes, one more extensive than the other, and then became ill with meningitis, Melinda began her long road of recovery. After she was diagnosed with cancer a second time, almost 15 years later, Melinda learned of Catholic Charities Community Services, where she began receiving service coordination, independent living skills training, and community integration counseling. And it was through these services that Melinda began to take her life back.

"It's transformed my life."

Some things are still difficult for Melinda to do on her own, so she continues to get help with managing budgets, helping with housing and employment opportunities. Melinda remarked that one of the best things that has come out of working with her CCCS team, though, is how they have helped Melinda regain her confidence. Her CCCS team is a safety net, so she doesn't have to worry about falling through again.

Today Melinda has a pet sitting business, she is finishing a memoir of her life's journey, she is an advocate for cancer patients and she sat on the Patients and Family Advisory Council (PFAC) at the Wilmot Cancer Center. Melinda takes harp lessons and had her first harp recital in June. She is an active member of Gilda's Club, and she won the prestigious Lisa Loopner Award for volunteering and teaching journaling workshops there.

Positive energy flows through Melinda, and she wouldn't have it any other way.





## Spirit

On September 16, 2013, Catholic Charities Community Services celebrated the installation of *Spirit*, its Horseson-Parade horse at the new office at Water Tower Park. The staff was joined by both the original artist, Belinda Bryce, and the artist who created a new base for *Spirit*, Mark McDermott. McDermott also moved and installed the horse.

Spirit was designed and painted by Belinda Bryce. Bryce's work has been featured in solo and group shows, on book covers, in national juried exhibitions, and in interior designer showcases. In the design of Spirit, Bryce incorporated several different translucent layers of golden acrylic and interference paint, and the layers symbolize movement through time—past, present and future—and space. The images of the people are actual individuals who received services from Catholic Charities Community Services. The overall effect of the design is meant to reflect the ups and downs and uncertainties of life, especially those felt by individuals living with HIV and AIDS. Both Bryce and McDermott donated their time and talent to this "labor of love."

Spirit spent 11 years "grazing" in the field behind CCCS' former location in Irondequoit. Time and weather took a bit of a toll on the horse's finish, and Belinda Bryce stepped up to refurbish the horse in anticipation of a move to a new indoor location. Spirit was released from a cement base and transported to the artist's studio. Metal and wood sculpture artist Mark McDermott created a new walnut base, suitable for indoor living.

Spirit continues to brighten up the new space, currently residing in the reception area.
